

PRIVACY POLICY

Protecting your private information is our priority. This Privacy Policy applies to and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Real Pride Network include www.realpride.network and RPN. By using the website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with membership services offered on our site, RPN may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Brokerage or other affiliation
- Profession
- Other member-submitted information, including your biography, website, photograph, preferred personal pronouns, sexual orientation, gender identity or expression, professional license number where applicable, and social media handles.

If you purchase services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Sharing Information with Third Parties

RPN does not sell, rent or lease its customer lists to third parties.

RPN may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to RPN, and they are required to maintain the confidentiality of your information. RPN may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on or the site; (b) protect and defend the rights or property of RPN.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by RPN. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the website.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information.

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Age of Majority

RPN does not knowingly collect personally identifiable information from anyone under the age of majority according to local laws.
